

**PAST AMERICAN FISHERMENS RESEARCH FOUNDATION (AFRF)  
PROJECTS 1971-2016**

The following is a year by year compilation of projects AFRF has undertaken and for what expense. Almost all of AFRF has been funded by industry contributions from fees of fish landed. The exception is NOAA funding for a segment of the archival tagging during the past decade. AFRF also spends on representation at international and federal management and scientific meetings. Since 2000 AFRF has spent nearly 1.5 million dollars on these efforts in order to maintain fleet access to the resource.

- 2016 (Year 15-16 of archival tagging/AFRF/SWFSC (\$ 142,000), \$ 500 Scholarship Contribution to 66<sup>th</sup> Tuna Conference
- 2015 Year 14 of archival tagging/AFRF/SWFSC (\$46,000), \$ 500 Scholarship Contribution to 65<sup>th</sup> Tuna Conference, 123 tags deployed in 2015, over 1,000 since 2001 with 29 recoveries plus 6 dummy tag recoveries, \$2,000 contributed to Dr. Ray Hilborn forage species study outlines by CA Wetfish Association, \$500 contributed to Ventura Fishermens Assoc to help on attorney letter costs concerning procedures carried out on the turtle hard-cap issue in the DGN fishery, but could affect albacore management decisions, \$1,000 allocated for AFRF public outreach canned or pouched albacore.
- 2014 Year 13 of archival tagging/AFRF/SWFSC (\$71,000), \$ 500 Scholarship Contribution to 64<sup>th</sup> Tuna Conference, SWFSC proposes plan to tag 5,000 albacore with conventional tags, so far funding is an issue. AFRF requests more be done privately or through NMFS to further develop useful E-Logbooks for those that want the option, so far pilot program over past 10 years on 10 vessels has been successful but technology getting out-dated, In-season tooling sampling an measuring continues.
- 2013 Year 12 of archival tagging/AFRF/SWFSC (\$50,000), \$ 500 Scholarship Contribution to 63<sup>rd</sup> Tuna Conference, Vessel onboard measuring and sampling ongoing, Hawaii tagging ongoing with issues.
- 2012 Year 11 of archival tagging/AFRF/SWFSC (\$50,000), 81 tags deployed, \$ 500 Scholarship Contribution to 62<sup>nd</sup> Tuna Conference, Vessel onboard measuring and sampling ongoing, Hawaii tagging continues with no success, AFRF, Oregon Albacore Commission, and AAFA working with processors and OSU Seafood Lab develop simpler time and temperature onboard fish handling protocol acceptable to USDA.
- 2011 Year 10 of archival tagging/AFRF/SWFSC (\$50,000), \$ 500 Scholarship Contribution to 61<sup>st</sup> Tuna Conference, handline tagging underway in Hawaii but difficulty catching, AFRF makes formal request to NMFS for \$250,000 for tagging research trip offshore in Mid-Pacific (no result).
- 2010 Year 9 of archival tagging/AFRF/SWFSC (\$50,000), Two tagging trips, first one by charter boat out of Westport, WA,\$ 500 Scholarship Contribution to 66<sup>th</sup> Tuna Conference, AFRF

approves initial funding to N. Committee of the WCPFC for \$1,000 and \$4,000 in-kind contributions for further sampling and processing sampled albacore.
